


Case study in state decision-making

Governor's Emergency Education Relief (GEER) fund

- \$4.3 billion awarded directly to governors for emergency education relief (two waves)
- Smallest of the Education Stabilization Fund programs but gave significant discretion to governors
- How did governors allocate funds?



GEER allocations varied significantly by state



No clear political trends

Centralized board systems more likely to receive higher ed \$


Table 1: States That Gave to Higher Education

States with:	Percent of States that Gave to HE	Share of GEER Given to HE
Republican Governor	84.6 %	49.6 %
Democrat Governor	88.0 %	45.3 %
High investment in HE	86.4 %	53.0 %
Moderate investment in HE	96.0 %	48.9 %
Single, statewide coordinating board	92.9 %	52.3 %
Multiple coordinating boards	78.9 %	45.0 %
All States	86.3 %	47.5 %


GEER allocation processes varied by state, but strongly relied on existing formulae

- **Georgia:** Respective proportion of students who receive the Tuition Equalization Grant
- **Virginia:** Existing state approach to award more funds to public institutions with students with higher unmet financial need; awards to private institutions based on their proportionate share of students.
- **Connecticut:** Same eligibility criteria and formula as the state's Roberta Willis Scholarship program.
- **Kansas:** Proportional to institution's share of the State General Fund operating appropriations

Lessons learned from GEER for the months ahead?


- State block grants to higher education are rare (RIP LEAP).
- While K-12 debates involve state block grants, higher education funding discussions are either around cuts (SEOG) or reductions (FWS)
- Where can states invest in supporting students and institutions?
 - Key higher education functions include research and data; opportunities for states to collaborate and leverage richer state data to inform the field
 - State role needed to guide residents through changing federal landscape; ex: communicating changes in aid to students
